  - D. Roofing Update Rich walked the roofs with a roofing consultant, talked about waiting to redo the roof and instead tuck pointing. Has some doors that should be replaced in lieu of the roof. Not concerned about pooling water, shouldn't be a problem for 20-25 years. Jean would like to have it double checked to make sure the water really isn't a problem. Mitzi suggests looking at the roof during storms to assess the rain collection. Rich will look into further consultation and revisit next month.
