 - A. Approve November Minutes approved.
 - B. Update on Food Service:
 - a. Staffing Current status? New Food Service Director in attendance, things are going well. Staff is excited and have already received comments about how the food is better. Some new changes have been made, bringing in new breakfast items, presenting food nicer, more seasonings, and etc.
 - b. Bar Line Second semester, On track? Bar line is still on track. Breakfast program is also in the works, many students are interested and they will be pursuing a breakfast line for second semester.
 - C. Roofing Update Estimate? As of 12/10/2021, no update. Will keep updated as information becomes available.
 - D. EES roof repair? Complete? Should be on the roof 12/20, and weather permitting should be done that week. Unable to get up there before Thanksgiving.
 - E. Lighting Installation Update? ENERGY HOUSE will be here starting 12/23 and be here over
 - F. Christmas to complete the LED conversion inside the building. The Outside lights have been done.
 - G. Bathroom Quotes? Have received two quotes, waiting for one more potentially. Turning the stall doors around for more room in the stalls. Hoping to have it completed by 11/19, Complete? Doors are all installed in the women's room, and need to be done in the men's room as well.
 - H. PES utilization Standard Process is interested in potentially renting out space for offices/conference rooms. Any update? They have declined to pursue it further.
 - I. Moving the Koi Pond from PES to EES? Would need to build a pond at EES, then move the fish, rocks and etc. Would be better to move in the summer months and not the winter. Also advised

- that it may be difficult to maintain and secure due to the lack of protection around the pond. Agreeing to keep it going, but leaving it where it is.
- J. Moving the Gaga Ball Pit PES to EES? They have a place to move it, Suggested it is moved off of concrete/asphalt. Discussed also creating a new one, but it shouldn't be that difficult to move. Will find out what it will take to move, and return next month.
- K. PA System at EES starting to breakdown, the board cannot be replaced unless you find it on a resale sight. This PA system is critical to operation in EES. The wiring is also poor quality, which is difficult to repair. Want to reuse the speakers, replace the wiring and a new unit. Have received three bids, IT Dept does recommend Advanced Communication Services Inc. DO will look into funding, discuss it again next meeting.
- L. Update on Security Cameras IT suggests moving cameras from PES that are not currently being used, and then purchase 5 more to replace existing ones. Will start with moving the unused cameras now, to move them to the important places that need them, and then work on the budget for new ones.
