- 1. Review of Minutes from August Approved.
- 2. Discussion of Activity Accounts- Tara spoke and is concerned about various reviews of the activity accounts concern about vendors being paid in a timely manner, updates of accounts, account balances, looking to take the money out of the accounts. Looking to have money more properly managed. It's on Kari's list, it needs to be discussed with Brad. It is a work in progress, due to the staffing changes over the last 18 months in the DO. Money has been moved to the proper funds. Checks will be cut on the 10th and the 25th every month. Will make a procedure list to update the boosters & clubs. Discussed whether or not PEASD should hold the funds for booster clubs, or if they should themselves. Can work on moving those accounts separately from the district, work on a packet for the booster clubs to know what they need to do. Follow up on this in a month.
- 3. Budget Status Working on position control, more accurate. General fund increase of 6.4%, could be less once they figure out the surplus. In the next two weeks it should become much more clear as we get more information from the auditors. (ask Brad for clarity here) This is done 3 months earlier than last year, thanks to DO work. Strongest financially in the last 10 years. The district is very strong financially. 34% fund balance- solid. Up 16 students this year.
- 4. Treasurer Reports Heavy outflow at the start of the year, no issues. Audit is complete and onlime for the annual meeting.
- 5. SP Complex Updates- focusing on how to improve relations with the benefactor, still working on it.
